### WASHAKIE COUNTY COMMISSIONER PROCEEDINGS July 23, 2024

The Washakie County Board of County Commissioners met at the above date beginning at 9:00 a.m. Those present were Chairman Aaron Anderson, Commissioner Terry Wolf, Commissioner Morgan Martinez and clerk to the board Lily Rakness Parra. The meeting was opened with the pledge of allegiance led by Commissioner Wolf.

Interim Planner Mike Robinson gave an update to the BOCC. He advised that all chip seal projects were moving forward. He advised that due to the current available materials being almost exhausted, Lane 14 and Washakie 10 may have to wait. Robinson advised that he could get quotes together with numbers and options. He also said that he is currently looking at options for patching up potholes on Road 13 close to Airport Road.

Building Maintenance Manager Breck Buer gave a maintenance update to the BOCC. He advised that they were moving forward with Fair week and all the ins and outs needed for that. Buer said that he has been in contact with Road and Bridge Superintendent Stuart Bower and that the parking lots have been kept watered down and that everything was going very well so far. Commissioner Wolf enquired about the awning for the Blue Grass Festival and Buer reported that there seemed to be conflicting stories regarding the cost and who would be responsible for it. Buer said that he will be in contact with Bloedorn Lumber to get estimates

Sheri Gunderson, Kassi Nolting and Lila Jolley gave an update on WCPC to the BOCC. Lila Jolley advised that they would be working on Suicide Prevention Trainings with the governor's office for the next three years with and online training which she advised would be extremely beneficial for all counties in Wyoming. She also said the Tyson Hoopes Memorial Golf Tournament was coming up and if anyone would like to participate or donate funds, they were welcome to. Kassie Nolting advised that the prevention was going very well and the meetings with the Worland Youth Learning Center were well received, and they will be continuing to meet. Sheri Gunderson said that the grants aspect of the program was going well, and she was currently working on this new Fiscal Year contracts. She gave an update on the grant that the library had recently submitted due to the need for additional funds for their project. A discussion was held regarding the new Grants Department for the State of Wyoming and the available training regarding applying for grants. The BOCC advised that they would be in support of Gunderson attending the new training coming up and Gunderson advised she would look into the training.

Public Health Coordinator Amanda Heinemeyer gave an update to the BOCC. She advised that they were currently having a canvas art contest that anyone in the community may participate in. She also requested permission to advertise for the PHRC position that will be open soon. The BOCC advised her to proceed.
