Interim Planner Mike Robinson gave a Planning update to the BOCC. He advised that the DEQ permits were in order and gave a gravel crushing update. Robinson said that the CMAQ reimbursement should be in soon and a discussion regarding gravel projects and areas in need of product for 2025 was held. Bower advised that due to the water leak on South Flat Village, the road will need repair or to be pulverized and brought back to gravel with dust control maintenance. Robinson updated the BOCC on the Planning Commission meeting and advised that the board had tabled the Ten Sleep Rock Ranch discussion until the December 8th comment period had passed. He also notified the board regarding a tentative subdivision and the details of easements etc. on Tie Down Road.

Building Maintenance Manager Breck Buer gave an update to the BOCC. He advised that Rapid Fire was currently doing the required maintenance and testing on the fire suppression and extinguishers as needed. Once completed, they will be main company maintaining all fire suppression and required inspections for Washakie County.

A motion was made by Commissioner Wolf and after removing himself from the chair, seconded by Commissioner Anderson to allow Chairman to sign the application for WAM Energy Lease Application pending review and approval from the rest of the Commission. Motion carried.

A motion was made by Commissioner Wolf and after removing himself from the chair, seconded by Commissioner Anderson to go into executive session with County Attorney Tony Barton to discuss personnel at 10:46 am. Motion carried.

A motion was made by Commissioner Wolf and after removing himself from the chair, seconded by Commissioner Anderson to adjourn the executive session and return to open session at 11:17 am. No action was taken.

Le Ann Baker with the Washakie Development Association presented the BOCC with Rural Business Development Grant Opportunity and the need for an Economic Development Strategy Plan. Those present were Worland Mayor Jim Gill, Tracy Glanz, City Planner Nick Kruger, Rebecca George, Tom Schmeltzer and Sheri Gunderson. The discussion revolved around the need for an Economic Development Plan for Washakie County, including the City of Worland and the Town of Ten Sleep. Baker advised that the grant would assist in funding the creation of an Economic Development Plan and that there was a 25% match for the requested funding. Baker also spoke to the benefit of the plan and its ability to show the infrastructural needs for all areas of the county. Chairman Anderson advised that the plan would give the entities a document to refer to when applying for grant funds under the umbrella of the plan. It was decided that the entities will move forward with applying for the grant. The BOCC advised that they were willing to assist in all aspects of the application as needed.
