Any creditor or other claimant shall make his or her claim in writing, to the Co-Trustees in care of James A. Box 552, Worland, WY 82401, within one hundred twenty (120) days of the date of first publication of this notice.

That pursuant to W.S. § 4-10-507 and W.S. § 4-10-604, any creditor failing to file his/her/its claim or person/entity failing to commence a judicial proceeding to contest the validity of the Trust or the proposed distribution by the Co-Trustees within the one hundred twenty (120) days provided is forever prohibited from making any claim against the assets of the Settlers/Trustors, and estates of Robert K. Hensman and Shirley I. Hensman, or those of The Hensman Family Trust dated February 5, 1990, or from commencing any judicial proceeding against the Settlor/Trustor's estate or the assets of the Settlor/Trustor's Trust.
