Public Health Nurse Manager Amanda Heinemeyer met with the board to review protocols regarding people that test positive for COVID-19. It was again emphasized that if a person tests positive or has symptoms they should stay home except to go to their doctor and not go out in the public to try to curb the spread of the virus. Currently Public Health is administering the COVID-19 vaccine by appointment. Amanda also reported that flu shot clinics have been scheduled beginning this week.

A motion was made by Commissioner Anderson and seconded by Wolf to convene into executive session with Public Health Nurse Manager Amanda Heinemeyer to discuss personnel at 9:37 am. Motion carried. A motion was made by Commissioner Wolf and seconded by Commissioner Anderson to reconvene into regular session beginning at 10:04 am. Motion carried. A letter will be sent to Department of Interior and Worland Field Office BLM employees regarding the federal mandate that all employees receive a COVID-19 vaccine. Washakie County Public Health is not regulating or requiring anyone to get the vaccine they are only supplying the vaccination.

Crisis Prevention & Response Center Director Karina Rice, Sheriff Steve Rakness, Assistant County Attorney Tony Barton, Banner Health Quality Safety and Infection Senior Manager Lisa Daniels-Kielmeyer met with the board to discuss a policy and procedures document that is needed regarding the Secure Digital Forensic Imaging (SFDI) camera. Discussion was held on upcoming training that is needed for all that will be using the camera and creating a policy and to make any necessary changes to the policy after training is complete. The U.S. Department of Justice is requiring that a policy and procedures is completed within 30 days because the camera was purchased with a federal grant. Tony will look for a template for a policy.

Road and Bridge Superintendent Keith Bower reported that repairs are needed on the grader and the backhoe. Estimates were received for the grader repair is \$7,316.25 and for the backhoe is \$2,245.00 Approval was given to repair both pieces of equipment. The sand has been received and the salt has been ordered for the winter sanding. Commissioner Frandson would like the debris cleaned on Lane 4 as soon as possible and discussion was held on spraying weeds more often and in more places. The crew may need in the future to spray more weeds due to the fact that mowing may not be available in the Ten Sleep area next year.

A motion was made by Commissioner Anderson and seconded by Commissioner Wolf to convene into executive session beginning at 10:32 am with Road and Bridge Superintendent Keith Bower to discuss personnel. Motion carried. A motion was made by Commissioner Anderson and seconded by Commissioner Wolf to reconvene into regular session beginning at 10:38 am. Motion carried. No action was taken.

Building Maintenance Manager Tom Schmeltzer met to discuss the furniture at the Library. At this time there are several parts that are still being shipped to complete the shelves and the door opener for one of the doors. Discussion was held on insulating the roof at the library. To spray foam insulation estimated cost is \$63,000.00. This could possibly be done on weekends and in sections. To place a new roof and insulation on the library estimated cost is \$97,000.00. Discussion was held on if there were any energy grants available to assist with the cost. The WAM energy grant could possibly be applied for but the funds cannot be spent until July 1, 2022. After further discussion regarding the rising costs of natural gas and going into the winter season a motion was made by Commissioner Wolf and seconded by Commissioner Anderson to approve spraying in the foam insulation for the library roof and to put the project out to bid. Motion carried.

Planner David Anderson and Building Maintenance Manager Tom Schmeltzer reported that they had reviewed the bids for an architect for an Ambulance Building. County Attorney John Worrall had several language changes that needed to be made to the contract and also discussed was a materials list that had been sent, costs for copies and other incidentals with the architect bid and projected end price of the project. A motion was made by Commissioner Anderson and seconded by Commissioner Wolf to table the awarding of the contract to Amundsen Associates until the county can ensure funding is available through the ARP funding and for the amendments that are needed to the contract. Motion carried.

Commissioner Frandson reported that there will be an Urban Systems meeting on November 9 that Commissioner Anderson will attend and Ron Harvey will remain on this board for the commissioners. Commissioner Frandson stated that due to the fact that the City of Worland may lose city status as per the census figures the funds will not be lost that have been received to date.

This could be counted as an in-kind donation and work toward matching funds for additional funds to become available. A lease agreement will be drawn up by the county attorney and Commissioner Frandson regarding the office space.
